## **VERIFIED GROSS MASS**

## AS REQUIRED BY SOLAS AND AMSA MARINE ORDER 42

- The safety of life at Sea Convention (SOLAS) and Australian Maritime Authority ("AMSA") Marine
  order 42 (cargo, stowage and securing) (MO42) require, as a condition for leading a packed container
  onto a vessel for export, that the Shipper provide a Verified Gross Mass to the Master (or their
  representative) and to the port terminal, in sufficient time to be used in the preparation of the
  vessel's stowage plan.
- 2. It is a breach of SOLAS and Australian law for a person to load a packed container onto a vessel if the Shipper has not provided a Verified Gross Mass to the master (or their representative)
- 3. Estimate of weight is not permitted
- 4. There are two permissible methods for determining the packed container's Verified Gross Mass:

Method 1: weighing of the container after packing and sealing; or

Method 2: weighing all of the cargo and contents of the container (including all pallets, dunnage and other packing and securing the material to be packed in the container), and adding those weights to the container tare weight.

Weighing equipment must meet Australian certification standard, or be approved by AMSA in accordance with MO42.
